कोविड-19 संक्रमण के मद्देनजर मध्य अंचल , खान सुरक्षा महानिदेशालय, धनबाद द्वारा आयोजित कनिय खनन परीक्षाओं (माइनिंग सरदार, गैस टेस्टिंग) के दौरान कार्यालय परिसर में अभ्यर्थियों के लिए मानक संचालन प्रक्रिया (S.O.P)

- 1 Authorization Letter के पृष्ठ भाग में दर्शाए गए **कोविड-19 संक्रमण के सम्बन्ध में परीक्षा के लिए निर्धारित मानक संचालन प्रक्रिया (SOP)** का अनुपालन अनिवार्य है ।
- 2 दफ्तर के प्रवेश द्वार में केवल प्राधिकृत प्रमाण पत्र (Authorization Letter) को दिखाने पर ही अभ्यर्थियों को कार्यालय परिसर में प्रवेश की इजाजत दी जाएगी और उसकी थर्मल स्क्रीनिंग की जायेगी ।
- 3 अभ्यर्थी के अलावा किसी अन्य व्यक्ति के प्रवेश पर पाबन्दी रहेगी ।
- 4 Authorization Letter में निर्दिष्ट समय अंतराल में ही अभ्यर्थी को दफ्तर के मुख्य द्वार से प्रवेश की अनुमति दी जाएगी ।
- 5 सभी परीक्षार्थियों को कार्यालय परिसर के एंट्री गेट पर थर्मल स्क्रीनिंग कराकर तथा हाथ सैनेटाईज करने के पश्चात ही प्रवेश करने की अनुमति होगी ।
- 6 यदि थर्मल स्क्रीनिंग के दौरान तापमान सामान्य से अधिक या अन्य कोई कोरोना के लक्षण पाए जाते हैं तो उन्हें प्रवेश की अनुमति नहीं होगी ।
- 7 कोरोना महामारी कन्टेनमेंट जोन में रहने वाले अभ्यर्थी को परीक्षा में सम्मिलित नहीं किया जाएगा । अतः उन्हें इस कार्यालय में आने की इजाजत नहीं दी जाएगी जब तक उनके कन्टेनमेंट जोन को denotify नहीं कर दिया जाता है । इस सम्बन्ध में स्व हस्ताक्षरित शपथ पत्र देना होगा के अभ्यर्थी कन्टेनमेंट जोन में नहीं रहता है ।
- 8 दफ्तरों में केवल उन्हीं परीक्षार्थियों को आने की इजाजत दी जायेगी, जिन्होंने फेस मास्क और हैण्ड ग्लव्स पहना हो । दफ्तर के भीतर भी पूरे समय फेस मास्क और हैण्ड ग्लव्स पहनना जरूरी है ।
- 9 अभ्यर्थियों को सोशल डीस्टेंसिंग और कोरोना के सम्बन्ध में सरकार द्वारा समय समय पर जारी नियमों का भी पालन करना होगा । सभी अभ्यर्थियों को कम से कम 2 मीटर की दूरी एक दूसरे से बनाये रखना आवश्यक होगा ।
- 10 अभ्यर्थियों को निर्देश दिया जाता है कि दफ्तर के परिसर, पार्किंग एरिया में भीड़ न जुटाएं जाय तथा सोशल डीस्टेंसिंग के नियमों का पूरा पालन करें ।
- 11 अभ्यर्थियों / परीक्षार्थियों को आने और जाने के लिए निर्धारित (Displayed) रास्ता का ही प्रयोग करना होगा ।
- 12 परीक्षार्थी को अपने फेस मास्क, फेस कवर, ग्लव्स या अन्य कोई वस्तु को दफ्तर परिसर में नहीं छोड़ना होगा ।
- 13 परीक्षा समाप्त होते ही अभ्यर्थी को महानिदेशालय के कार्यालय परिसर से तुरंत बाहर चला जाना होगा ।
- 14 परीक्षा का Result Website पर परीक्षा के दिन या दूसरे दिन Upload किया जायेगा , अतः Result देखने हेतु अभ्यर्थी को कार्यालय परिसर में रुकने की आवश्यकता नहीं है ।
