## **AFFIDAVIT**

- I, Girirao S/o Bhimraoji Nagpure, aged about 66 years, Assistant General Secretary, Indian National Mineworkers' Federation, presently resident of Nagpur in the State of Maharashtra do hereby state as under on solemn affirmation.
- That I am the Assistant General Secretary of Indian National Mineworkers' Federation having its Hd. Qtrs at Dhanbad in the State of Jharkhand and I am competent to affirm the Affidavit in respect of the matter referred to this Forum of Court of Enquiry. The Indian National Mineworkers' Federation is one of the Industrial Federations of Indian National Trade Union Congress (INTUC in brief) and the said Federation looks after the Welfare & Safety of all the persons employed / engaged in the mining activities of all Minerals in India.
- 2) That I am holder of competency certificate of Overman granted to me by the Secretary, Board of Mining Examination, Dhanbad, Office of the Directorate General of Mines Safety, Dhanbad and the said certificate was granted to me in the year 1981.
- 3) That I am conversant with Opencast Coal Mine working activities and was discharging the functions of Overman a competent person under Coal Mines Regulations, 1957 revised in the year 2017.

Subsequent to the said occurrence of the above accident on 29.12.2016, I had some regular interaction with the constituents of Indian National Mineworkers' gathered the information from which it was revealed that the site of excident and the coal mining operation activities sanction / approval along with the Rules and Orders were not obtained by the Colliery Manager, Agent and the Owner of Rajmahal Opencast Coal Mine thus they have resorted to illegal mining activities since

prior to about three years of occurrence of the accident of Rajmahal Opencast Coal Mine Project.

6) I have to further state that according to the information gathered by me the entire coal mining activities such as removal of overburden (top soil of coal seam) contractually and there was acute shortage of statutory supervisory personnel such as Mining Sirdars, Overman, 2<sup>nd</sup> Class Certificate Holder Assistant Manager, 1<sup>st</sup> Class Certificate Holder Assistant Manager and neither the management of Eastern Coalfields Ltd nor the outsourcing agency had not maintained the records of Form-'B' register under Mines Rules, 1955 and none of the outsourced employees were imparted Basic / Initial Training under Mines Vocational Training Rules, 1966 and no certificates of Vocational Training were granted to the outsourced workers by the Vocational Training Officer of the Rajmahal Coal Mines, Eastern Coalfields Ltd.

7) That I have to further state that it is also gathered that neither the outsourcing agent for the Coal Mine Manager of Rajmahal Project maintained the attendance register about actry into workplace and exit in workplace in Form-'D' register under Mines Ralles 1856.

Rajmahar Coal Mine did not obtain the sanction of Chief Inspector of Mine (Director eneral of Mines Safety) to carry out the safety management plan based on risk assessment and no prior sanction was obtained to carry out the scientific approval from the Directorate General of Mines Safety by submitting the design thereof which is a mandatory requirement under the statute as stated by the then Director General of Mines Safety, Dhanbad (Sri Rahul Goha).

9) That I have to further state that no prior approval of the working plan of the accident area for removal of over burden and extraction of coal was obtained by the Colliery Manager, Agent and Owner of Rajmahal Opencast Coal Mine.

That I have to further state that the site of the accident area was earlier filled with diverburden extracted from other site of the said opencast mine which was found as a fleap and the said heap was lying in loose form and before initiating the coal mining activity of the accident site the Colliery Manager, Agent and the Owner did not take any steps as a matter of abundant mine safety precaution by leveling the said over burden

dump having a height of about 150 meters from the ground level and no leveling of the overburden dump by spreading the over burden dump with mechanical means by way of dozing the area, heavily water sprinkling of the dozed area and rolled out the water sprinkled area with road rollers so as to undue that the entire over burden dump was strongly settled and stranded and because of not taking the above stated mines safety precaution the accident occurred due to spalling of the over burden dump consisting of large size hard stone boulders which had hit the working heaviest moving machinery engaged for removal of over burden and extraction of coal.

- That I have to further state that it was also gathered that no proper benching of 11)over burden area was prepared having the width of atleast not less than 30 feet of each bench and the height of each bench was not maintained as required under Coal Mines at the height of the over burden bench from the coal mining site was than 60 feet and the large size hard stoned boulders dumped in the divilled down from over burden dump to the coal mining activity site the huge quantity of loose soil dumped on the working Heavy Earth Moving Mather 6HE engaged in the coal mining area resulting into loss of lives of 23 utsourced workers) and the entire debris had totally fallen on the Moving Machinery consisting of Dumpers, Dozers and Coal loading machines (which are known as Excavators).
  - It is also gathered that the Colliery Manager, Agent and the Owner of Rajmahal 12) Coal Mine were carrying out the activities of removal of over burden and extraction of coal from nearby site departmentally against the permission granted by the Directorate General of Mines Safety.
  - That I have to further state that the Mining Sirdar as well as the Overman 13) engaged in the accident site to supervise the coal mining activity being the statutorily authorized supervising personnel had recorded in their Daily Report Books for the last many a days that the height of the over burden bench from coal extracting area was much-much-much higher than the permissible limit under the statute and also stated further continuing the activity of coal extraction from the coal seam should be

gathered that the above statutory supervisory personnel had also daw reports that wide cracks are developed in the high benched over

which may spall heavily at any time.

- That I have to further state that the daily report of the Mining Sirdar and the Overman of each shift is required to be examined by the Colliery Manager every day and take necessary steps to rectify the irregularities pointed out by the said supervisory personnel but the Colliery Manager is reported to have not perused the daily reports of the Mining Sirdars and Overman thus the Colliery Manager did not discharge his statutory duties which resulted into the accident leading to loss of lives, damaged of machineries etc.
- That I have to further state that the local officials of Directorate General of Mines Safety are required to carry out inspections of the coal mining activity periodically and appraise the violation to the Colliery Manager, Agent and the Owner for its rectification within the prescribed time. It is further gathered that no such periodically inspections of the site of the accident was carried out by the Competent Inspecting Authorities of Directorate General of Mines Safety, inspite of the facts that the coal mining activities in the site of accident was being carried out was brought to the knowledge of the Inspecting Authorities of the said Directorate. Thus the concerned Competent Authorities of the said Directorate had failed to discharge their statutory functions which resulted into the said mine accident causing loss of 23 lives, damage to machinery valued three rupees.
- That I have to further state that the Colliery Manager, Agent and the Owner of Rajmahal Coal Mine Project were allowed to carry out the coal mining activity in the accident site by the Competent Authority of Directorate General of Mines Safety by removing the notice issued under Section 22 of Mines Act, 1952 without properly inspecting the area and also without having obtained the scientific study report of the accident area which is a serious lapse on the part of the concerned officials of said Directorate.
- That I have to further state that the outsourced workers who lost their lives in the accident and other remaining outsourced workers engaged in the said mining activity were not enrolled as members of the Coal Mines Provident Fund (CMPF) and the called pager, Agent and Owner of Rajmahal Opencast Project neither take any of the course of the outsourced workers as members of the Coal Mines Provident Fund nor the said Colliery Manager did not recover the amount of Coal Mines Provident Fund from the bills of payment paid to the

contractor from time to time thus the Colliery Manager of Rajmahal Opencast Coal Mine failed to discharge his statutory duties under Coal Mines Provident Fund Act, 1948.

- That I have to further state that the eligible dependant of the outsourced workers should be given employment by the Eastern Coalfields Ltd in their Mines and Establishments and place them under the scales of pay and allowances prescribed under National Coal Wage Agreement-X as was done in respect of a mine accident of explosion occurred in Chirimiri Coalfields in the District of Koriya (Chhattisgarh) about 4 to 5 years back of Rajmahal Mine Accident and the dependants of the said outsourced workers should be given employment commensurate to their qualification.
- 19) That I have to further state that the subject matter mine accident occurred due to negligent discharge of their duties and functions by the Managerial Personnel of Rajmahal Coal Mine of Eastern Coalfields Ltd such as 2<sup>nd</sup> Class Assistant Manager, 1<sup>st</sup> Class Assistant Manager, Mines Safety Officer, Colliery Manager, Agent, Owner, Obstacing Agency Company including its Directors and concerned Inspectorate of Directorate General of Mines Safety and they should be held guilty.
