FATAL ACCIDENTS IN MINES

During the year 2024, there were 38, 32 and 01 fatal accidents involving 40 and 31 fatalities in coal, metalliferous and oil mines respectively. The numbers of fatal accidents during the previous year i.e. 2023 were 38, 28, and 0 for coal, metalliferous and oil mines respectively.

In the year 2025, during the first half there were 23, 12 and 3 fatal accidents in coal, metalliferous and oil mines respectively resulting into 27, 14 and 4 fatalities and serious bodily injuries to 2, 6 and 0 persons in coal, metalliferous and oil mines respectively. The accidents are being inquired into. The accidents analysis is as shown below:

SERIOUS ACCIDENTS IN MINES

During the year 2024, there were 118, 27 and 04 serious accidents involving 125, 55 and 5 persons seriously injured in coal, metalliferous and 5 in oil mines. The numbers of serious accidents during the previous year i.e. 2023 were 117, 27, and 8 involving 130, 55 and 8 persons seriously injured in coal, metalliferous and oil mines respectively.

In the year 2025, **during the first half** there were 57, 13 and 0 serious accidents involving 58, 13 and 0 person seriously injured in coal, metalliferous and oil mines respectively. The accidents are being inquired into. The accidents analysis is as shown below:

Subject: Quality and conditions of explosives provided for use in mines.

- **1.0** Reg. 183 of the Coal Mines Regulations, 2017 and Reg. 153 of Metalliferous Mines Regulations, 1961 require that the explosives provided for use by the Owner, Agent or Manager shall be of good quality and in good condition. It has come to the notice of this Directorate that suitable checks and controls have not been provided at every mine magazine to comply with the said requirement. Needless to mention that use of explosives which are not in good condition may leads to hazards which are avoidable through proper check and monitoring the established mechanism.
- **2.0** In a span of 5 years (2019 to 2024), there were 21 fatal accidents in mines due to the explosives resulting in 44 fatalities and serious bodily injury to 12 persons. The analysis reveals that the major causes of the accidents occurred due to Misfires/Sockets (While drilling into), accidental initiation, Deep Hole Blasting Projectiles, Secondary Blasting Projectiles, Delayed ignition, Unsafe Blasting Practices etc.
- **3.0** Recently after an accident of blast of explosive materials in an opencast coal mine, test of Electronic Detonators being used in the mine were conducted at CSIR-CIMFR, Dhanbad where few batches of the Electronic Detonators did not fully comply the requirements of the quality standard (prescribed BIS norms).
- **4.0** Some of the Standards, circulars/guidelines issued in past, on the subject matter are as follows:

- **5.0** All manufacturers of the explosives and detonators and concerned test houses are advised to comply with the above guidelines or their revised version.
- **6.0** All user(s) of the explosives and detonators may ensure through a proper mechanism established for the purpose that such products have complied with the relevant standards and guidelines before putting them into use in mines.

In this regard immediate steps shall be taken to develop & implement suitable mechanism (checks and controls) to comply with the aforesaid statutory requirement so as to prevent untoward incidences causing loss of life and property.

Sub: Guidelines on minimum air quantity required at Continuous Miner and Long- wall panels.

1.0 Introduction: Regulation 153(1) of the coal Mines Regulations, 2017 (CMR 2017) mandates that owner, agent or manager of every mine to take such steps as are necessary to constantly provide in all parts of the mine belowground which are not sealed off, adequate ventilation to clear away smoke, steam and dust, to dilute gases that are inflammable or noxious so as to render them harmless, to provide air containing sufficient oxygen and to prevent such excessive rise of temperature or humidity which may be harmful to the health of persons.

As per the existing norms [sub-clause 2 (a) of Regulation 153 of CMR 2017], in order to ensure ventilation in every ventilation district, not less than 6 m³ per minute of air per person employed in the district on the largest shift or not less than 2.5 m³ per minute of air per tonne of daily output, whichever is larger, should pass along the last ventilation connection (LVC) in the district which means the in-bye most gallery in the district along which the air passes. To comply with this rule, a large quantity of air is to be delivered in the LVC of the mass production panels (MPP), as the daily Coal production in MPP is very high. This large air quantity may generate excessive dust in the LVC of MPP and develop a high water gauge in the main mine mechanical ventilator. The high ventilation pressure may accelerate the chance of spontaneous heating and endanger the overall safety of the mines.

2.0 Background Study and outcome: R & D project tilled **"Requirement of Air in Mass Production Technology"**, was conducted by CMPDIL, Ranchi to address the above challenges in ventilation of MPPs. Subsequent to successful completion of this R&D project, a workshop on "Assessment of ventilation requirement for underground Coal Mines adopting mass production technology in India" was organized jointly by M/s ECL and M/s CMPDIL at Jhanjra Project of M/s ECL and detailed deliberations were made in the presence of professionals, researchers and academicians.

Subsequently CMPDIL collected data from one development & two depillaring Continuous Miner (CM) panels and two different Longwall panels of coal mines for an in-depth study on humidity, dust, clearance/limit of noxious and inflammables gases for the life cycle of

development and extraction of CM and longwall panels, analyzed the same and recommended as follows:

A- For Continuous Miner Panels:

(i) Minimum air quantity (m^3/s) required at Last Ventilation Connection(LVC) of CM Panel (Q_{min}):

In Degree-I and Degree-II gassy coal mines:

 Q_{min} at LVC $(m^3/s) = 3 \times A_{max} \times 0.5 \text{ m/s}$ of air velocity.

In Degree-III gassy coal mines:

 Q_{min} at LVC (m³/s) = 3 x A_{max} x 0.75 m/s of air velocity.

A_{max} is cross-sectional area in m², of the gallery with maximum dimension in the panel.

(ii) To maintain a relative humidity not exceeding 80% in Mass Production Panels, at least 2°C temperature difference between the DBT and WBT is advisable to be maintained, which can ensure a comfortable environment for the miners to work in a safe and healthy environment.

To restrict maximum 2° C rise in temperature due to machines, at least 25 m³/s of air is to be delivered in the LVC of mass production CM panels.

B- Power Support Longwall (PSLW) panel:

(i) To achieve a comfortable working environmental in PSLW face and 2° C temperature difference between the DBT and WBT at least 3 m/s of air velocity is required; consequently, minimum air quantity (m³/s) required at PSLW Panel (Q_{min}),

 Q_{min} = Cross-sectional Area of maximum span of PSLW face in $m^2 \times 3$ m/s air velocity.

(ii) To restrict maximum 2°C rise in temperature due to machines, at least 60 m³/s of air to be delivered in PSLW.

Note- The minimum air quantity requirement for Mass Production Panel (MPP) should be calculated considering all of the aforementioned criteria individually, and whichever is the highest shall be delivered in the LVC of CM Panel or in PSLW Panel.

3.0 In view of the above study, it is advised that while ventilation planning of CM and PSLW panels, the above calculations of minimum air quantity requirement may preferably be used.

However, after commencement of the Mass Production Panels, a ventilation scheme shall be prepared on the basis of the factual conditions of the specific mine in compliance of the provision under sub-regulation (2) of the Regulation 153 of the Coal Mines Regulation, 2017.

Subject: Heat Wave in Summer and Precautions Against Accidents/Incidents Due to Exposure to High Temperature

The Owner, Agent and Managers of all Mines

1. Introduction

During peak summer seasons, high atmospheric temperatures have led to numerous incidents affecting mine workers, including fatalities. Opencast mines are particularly vulnerable, while inadequate ventilation in underground mines can also lead to heat-related illnesses. DGMS has circulated guidelines from time to time on Heat Wave in Summer and Precautions Against Accidents/Incidents due to exposure to high temperature, which are as follows:

- (i) The physiological effects of exposure to high atmospheric temperatures during the summer months and the guidelines for dealing with the situation were outlined in Circular No. DGMS (Tech) Circular (OH)/01, Dhanbad dated 24th April 2023.
- (ii) Circular No. DGMS (Tech) Circular (OH)/01, Dhanbad, dated 19/04/2024, outlined recognizing the Symptoms of Heat Stress and taking preventive measures, Do's and Don'ts while treating the person with symptoms of Heat Stress.

These guidelines shall be strictly followed.

2. Physiological Effects of High Atmospheric Temperature

- Heat Stroke: Major cause of fatalities, leading to rapid rise in body temperature and dysfunction of vital organs.
- (ii) Heat Rash: Red blisters formed due to the inability of sweating to evaporate, especially in areas of high sweat accumulation.
- (iii) Sunburn: Damage to skin resulting in redness, heat sensation, and possible blistering.
- (iv) Heat Fatigue: Impaired performance and judgment due to heat exposure.
- Heat Cramps: Painful muscle spasms often due to electrolyte imbalance from excessive sweating.
- (vi) Heat Syncope: Fainting caused by inadequate blood flow to the brain due to heat exposure.
- (vii) Heat Exhaustion: Dehydration and electrolyte imbalance leading to weakness and various symptoms.

- (v) Awareness and Training: Conduct training on recognizing symptoms of heat stress, such as dizziness and fatigue, and the importance of early reporting.
- (vi) Weather Monitoring: Track daily temperature and humidity levels to adjust work activities accordingly, utilizing heat index measurements to assess risk.
- (vii) Regular Health Check-ups: Perform regular health assessments, focusing on those at risk for heat-related Illnesses, and provide access to medical services.
- (vii)Nutrition: Encourage a balanced diet rich in fruits and vegetables to promote hydration and energy levels.
- (ix) Cooling Technologies: Offer personal cooling devices, like vests or fans, to help workers stay cool in extreme heat.
- (x) Peer Support: Foster a supportive environment where coworkers monitor each other's welfbeing and encourage reporting of heat stress symptoms.

7. For Children in Creches

- (i) Safe Environment: Ensure creches are located in shaded or air-conditioned areas and use thermal insulation to keep interiors cool.
- (ii) Regular Hydration: Provide easy access to clean drinking water and encourage caregivers to regularly monitor children's hydration levels.
- (ii) Outdoor Activity Management: Schedule outdoor activities in early morning or late afternoon, limiting them during peak heat hours.
- (iv) Protective Gear: Apply sunscreen before outdoor play and provide hats and lightweight clothing to safeguard against sun exposure.
- (v) Health Monitoring: Train caregivers to recognize symptoms of heat stress in children and ensure prompt action if any signs appear.
- (vii) Emergency Plans: Develop clear protocols for handling heat-related emergencies, including first aid responses and access to medical facilities.

B. For Creches and Families

- Nutrition: Promote nutritious meals that provide energy without heavy fats, incorporating fruits and vegetables with high water content.
- (ii) Parent Education: Engage families with information on caring for children during extreme heat, emphasizing rest and hydration.
- (ii) Regular Training: Conduct workshops for caregivers on heat stress prevention, recognizing symptoms, and ensuring children's comfort and safety.

9. Conclusion

Therefore, prioritizing the well-being of mine workers, women workers, and children in creches through comprehensive heat safety measures is crucial. By implementing the guidelines provided, mining operations can significantly reduce the risk of heat-related illnesses and ensure a safer working environment during the summer months. Continuous education, diligent monitoring, and a commitment to proactive strategies are essential for maintaining a healthy and secure environment for all.



खनन कर्मियों को बारूद के सुरक्षित उपयोग और नियमों की जानकारी दी

रामगढ़ में सिलिकोसिस से बचाव और सुरक्षा कानूनों पर दिया प्रशिक्षण

रामग्रह ब्लॉक के खनन क्षेत्रों में कार्यरत खनन किंमियों के स्वास्थ्य और सुरक्षा को लेकर खान सुरक्षा निदेशालय अजमेर की ओर से गागरूकता कार्यक्रम किया गया। खान सुरक्षा निदेशक डॉ. अई. सत्यनारायण ने मांदला खुर्द और पूंठी स्टोन माइंस का दौरा किया और वहां मीजूद खनन श्रास्कों व स्टोन क्रेशर मजदूरों को सिलिकोसिस बीमारी, खनन सुरक्षा कार्नों और गर्मी से बचाव के उपायों की जानकारी दी। डॉ. सत्यनारायण ने बताया कि

डॉ. सत्यनाययण ने बताया कि सिलिकोसिस एक गंधीर फेफड़ों की बीमारी है, जो धूल के लंबे समय तक संपर्क में रहने से होती है। इस बीमारी से बचने के लिए धूल नियंत्रण उपायों का पालन करें, मास्क और सुरक्षात्मक उपकरण नियमित रूप से पहनें, खनन स्थलों पर धूल को गीला करने की व्यवस्था होने की जानकारी दी।
