
## ANALYSIS OF FATAL ACCIDENTS IN MINES (JANUARY TO SEPTEMBER-2024)

During the period of January to September 2024, 60 fatal accidents occurred in the mines resulting in 70 fatalities shown below.

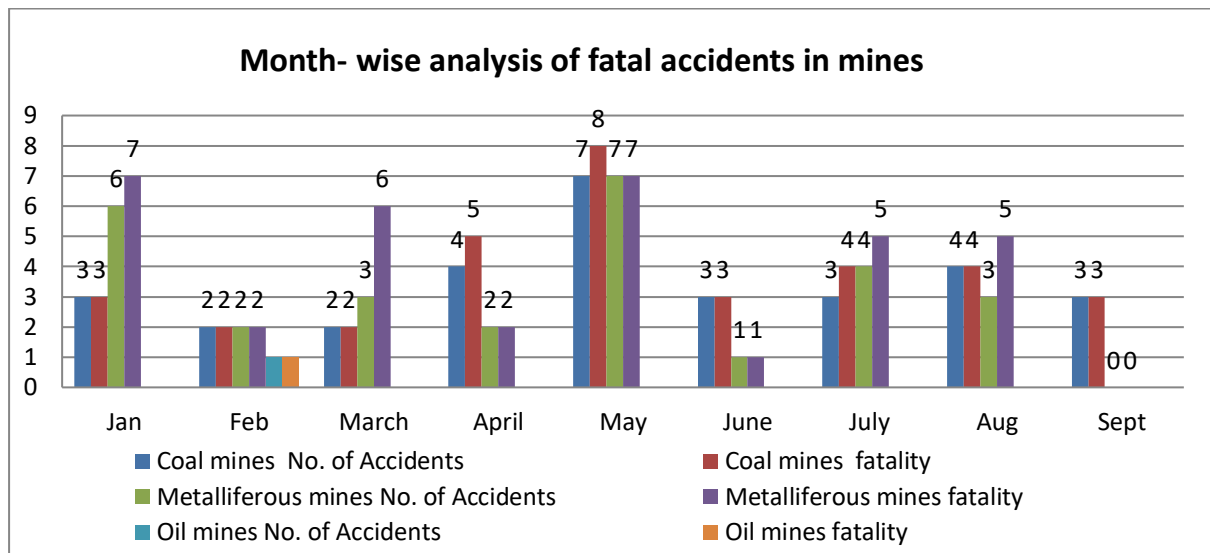

- In Coal Mines, 31 fatal accidents occurred resulting in 34 fatalities from January to September, 2024. The number of fatal accidents in the same period to previous year 2023 (January to September ) is 36 fatal accidents and 39 fatalities
- In Non-coal mines, 29 (Including 1 accident in Oil Mines) fatal accidents occurred resulting in 36 fatalities (Including 1 fatality in Oil Mines) and 21 seriously injured (no injury in Oil Mines) in these fatal accidents. The number of fatal accidents has increased as compared in the same period to previous year 2023 (January to September) with 25 fatal accidents and 30 fatalities.

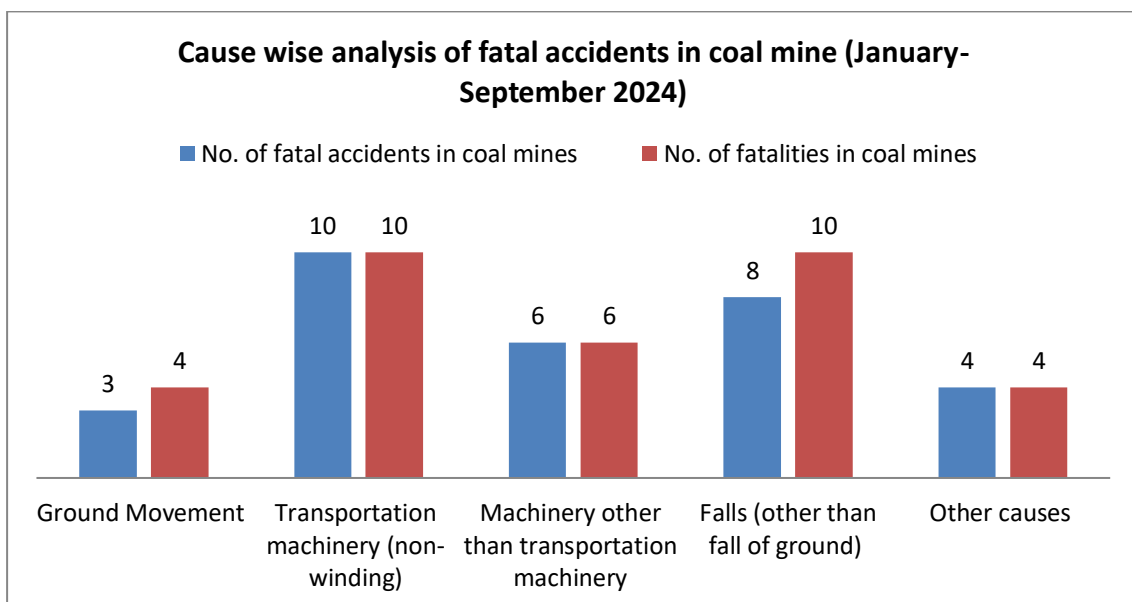

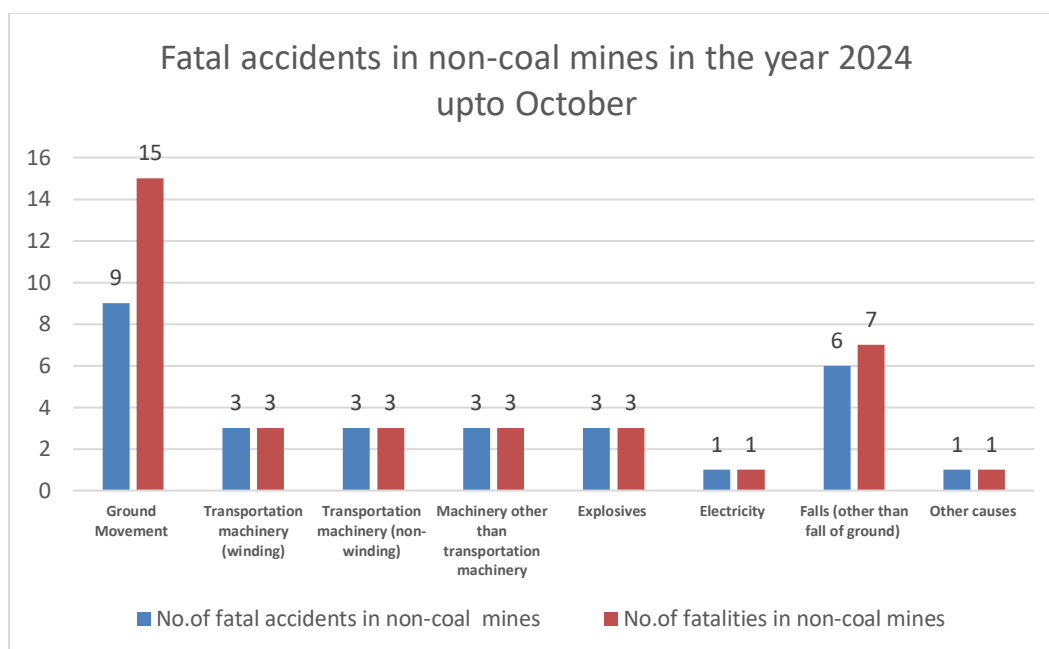

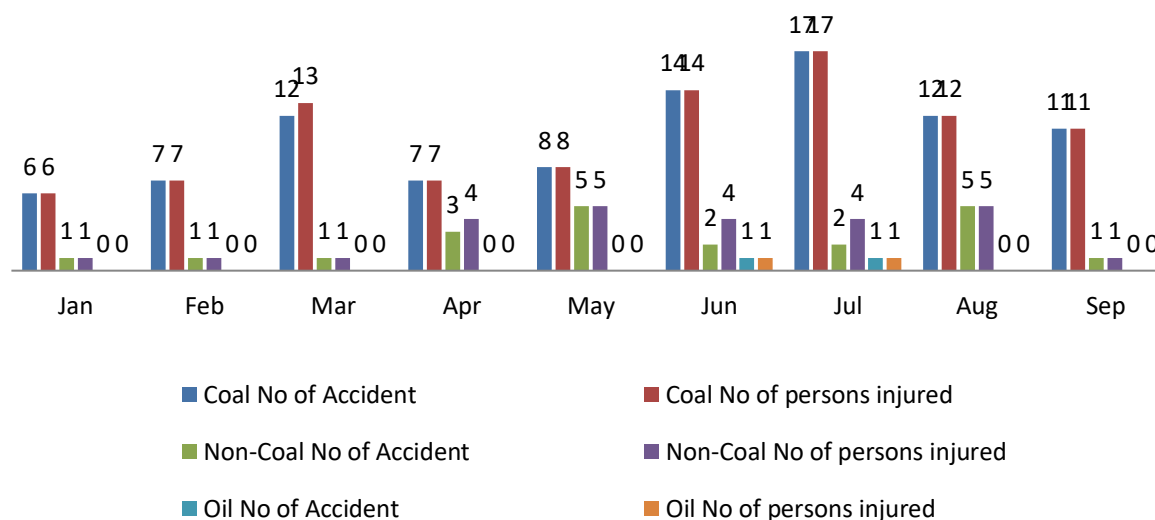
