CANDIDATES WHO HAVE NOT PASSED SENIOR SECONDARY SCHOOL EXAMINATION  
OR INTERMEDIATE EXAMINATION OR ITS EQUIVALENT FROM A BOARD  
RECOGNIZED BY THE CENTRAL GOVERNMENT.**
