- 1. Interested Parties may submit their highest prices for each vehicle individually in a sealed cover latest by 5:00PM on or before 15.02.2022.
- 2. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this Department. The condition of the vehicles lying in the office premises of Dy Director General of Mines Safety, Northern Zone, Directorate General of Mines Safety, CGO II, Hapur road, Ghaziabad (UP) PIN-201002 can be inspected physically between 11:00AM to 4:00PM on any working day between 1st Feb 2022 to 10th Feb 2022 by contacting Director of Mines Safety (Mechanical).
- 3. The vehicles are sold on scrap basis only and the successful bidder should cut the chassis number plate and hand over the same to this offices.
- 9. The sold vehicles will be removed by the successful bidder(s) within seven working days of depositing the money at their own expenses after that a penalty of Rs. 500/- per day will be charged. Taxes, if applicable, will have to be paid by the successful tenderer over and above his offer as per Government Rules. No assistance/transpiration will be provided by Directorate General of Mines Safety, Ghaziabad. Permission to take out the disposed vehicles from Directorate General of Mines Safety premises will not be allowed on holidays, Saturday and Sunday etc.
